POLICIES. THE EMBASSY BELIEVES THAT ANY COMMITMENT TO "ROLLBACK" GATT-INCONSISTENT MEASURES SHOULD APPLY TO DEVELOPED AND DEVELOPING COUNTRY ALIKE--AS BRAZIL HAS APPARENTLY PROPOSED--AND SHOULD PROVIDE AN ADDITIONAL INCENTIVE FOR AN EFFORT, HOPEFULLY MULTILATERAL, TO APPLY IT TO BRAZIL'S NUMEROUS GATT-INCONSISTENT TRADE RESTRICTIONS. END SUMMARY.

3. BRAZIL HAS BEEN PUSHING THE CONCEPT OF "STANDSTILL AND ROLLBACK" HARD IN THE PREPARATORY WORK FOR THE NEXT GATT MULTILATERAL TRADE NEGOTIATIONS (MTN) ROUND.
BRAZIL'S STARTING POSITION (GATT PREPCOM (86)W/3 OF MARCH 20, 1986) APPLIED THE "STANDSTILL" TO ALL COUNTRIES BUT THE "ROLLBACK" ON MEASURES "INCONSISTENT WITH GATT OR NOT BASED ON SPECIFIC GATT PROVISIONS" ONLY TO THE "DEVELOPED CONTRACTING PARTIES IN FAVOR OF DEVELOPING CONTRACTING PARTIES". THIS POSITION WAS REITERATED IN THE BRAZILIAN (I.E., G-10) DRAFT DECLARATION FOR THE PUNTA DEL ESTE MINISTERIAL. HOWEVER, DURING A RECENT CONVERSATION (REF A), WE WERE TOLD THAT BRAZIL HAD MODIFIED ITS POSITION SO THAT THE "ROLLBAC

WOULD APPLY TO BOTH DEVELOPED AND DEVELOPING COUNTRIES (WE HAVE NOT SEEN THE TEXT, HOWEVER). THIS WOULD BRING THE DEVELOPING COUNTRY COMMITMENT BETTER INTO LINE WITH THE G-9 DRAFT DECLARATION SUBMITTED TO THE PREPCOM ON JUNE 11, WHICH ALSO CALLED FOR THE COMMITMENT TO "STANDSTILL AND ROLLBACK" TO APPLY EQUALLY TO BOTH.

IF A CREDIBLE "ROLLBACK" COMMITMENT EMERGES FROM THE PUNTA DEL ESTE MEETING, THIS TOO COULD BE USED AS AN ADDITIONAL ARGUMENT TO PRESSURE THE GOB TO ELIMINATE ITS GATT-INCONSISTENT PRACTICES. AND OPPORTUNITY FOR THIS. BRAZIL'S INSISTENCE ON THE IMPORTANCE OF THE "STANDSTILL" AND ITS ACQUIESENCE IN APPLYING THE "ROLLBACK" TO DEVELOPING COUNTRIES SHOULD EVEN GIVE US A BIT OF HIGH MORAL GROUND.

7. IN OUR VIEW, THE LAW OF SIMILARS IS THE MOST ONEROUS OF THE GOB'S GATT-INCONSISTENT MEASURES. A "STANDSTILL AND ROLLBACK" COMMITMENT WHICH APPLIES TO ALL GATT/MTN PARTICIPANTS WOULD ALSO PROVIDE AN OPPORTUNITY TO PRESS THE GOB TO EITHER ABOLISH ITS PROHIBITED IMPORTS LIST OR TO MAKE IT GATT-CONSISTENT-HOPEFULLY BASED ON SOMETHING MORE RELEVANT THAN ARTICLE XII BALANCE-OF-PAYMENTS JUSTIFICATIONS.
