



Q2 Have you attended any of the TPPA negotiating rounds?



Q3 Do you have opinions about Ambassador Froman's performance as regards the TPP negotiation?



















Q12 Which USTR officials seem to represent President Obama's promise of Hope and Change and concern for the poor? (answer all that apply)



Q13 Most likely to eventually take a job working for PhRMA or its member companies?



Q14 Most likely to eventually take a job working for the MPAA?


