Signatures have been redacted pursuant to U.S.C. §552(b)(6), which pertains to personnel and medical files and similar information where disclosure would constitute and unwarranted invasion of personal privacy.

Inasmuch as this constitutes a complete response to your FOIA request, I am closing your file in this office.
